The undersigned for themselves and the company further agree to pay a service charge to ASSI at the maximum rate allowed by the laws of the jurisdiction where the originating ASSI location stated on the invoice is located on all delinquent balances as well as all costs and expenses ASSI may incur in connection with the collection of any balance or any other default by the company of any agreement or transaction the company may enter into with ASSI, including without limitation reasonable attorney's fees and all other fees arising from placement of collection.

This is a guaranty of payment and not of collection and the undersigned further waives any right to require that any action be brought against the company of any other persons or to require that resort be had to any security. The undersigned's obligation shall remain effective and be enforceable regardless of any subsequent incorporation, reorganization, merger or consolidation, transfer for sale of the company or any other change in the composition, nature, personnel or location of the company. This guaranty shall inure to the benefit of ASSI, its successors and assigns and shall bind the heirs, executors, personal representatives, administrators, assignees, purchasers and other successors of the undersigned.
